On May 15, 2018, a closed pre-submittal meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and representatives of Susquehanna Nuclear, LLC (the licensee) at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, Maryland. The purpose of the meeting was to discuss a proposed license amendment request to allow the use of Atrium 11 fuel for the Susquehanna Steam Electric Station, Units 1 and 2. The discussion included proprietary information.

During the meeting, the licensee presented information regarding the schedule to submit, review, and approve the license amendment request. The NRC staff asked several clarifying questions. The licensee stated that comprehensive TS page markups will be provided as part of the final submittal of the license amendment request to the NRC. No regulatory decisions were made during the meeting. A list of attendees is enclosed.
