On November 16, 2017, the U.S. Nuclear Regulatory Commission (NRC) completed a cyber security related Problem Identification and Resolution inspection at theThree Mile Island Nuclear Generating Station – Unit 1 (TMI). The inspection covered one or more of the key attributes of the Security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results, which were discussed on November 16, 2017, with Mr. Ed Callan, Site Vice President, and other members of your staff.

The inspection examined activities conducted under your license as they relate to safety and compliance with the Commission's rules and regulations, and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed station personnel.

The NRC inspectors did not identify any finding or violation of more than minor significance.
